# **Community Consultation for Large Developments**

New pre-Development Application (pre-DA) community consultation requirements for larger scale development proposals came into effect on 13 December 2012.

The new requirements are based on a 2010 trial community consultation process for certain larger development proposals. Proponents of development applications for these proposals have had to complete an approved form containing a community consultation summary and include this as part of the development application.

In December 2011, legislation was passed to mandate the pre-DA community consultation process and allowed a 12 month implementation period before commencement. The new requirements are now in force.

Pre-DA community consultation must be conducted when a development proposal triggers one or more of the following:

- the proposal is for a building for residential use with 3 or more storeys and 15 or more dwellings
- the proposal is for a building with a gross floor area of more than 5000m<sup>2</sup>
- the proposal is for a building or structure more than 25m above finished ground level
- the proposal is for a variation of a lease to remove its concessional status.

The proponent will determine the type of community consultation that they will complete.

Development proposals in an industrial area are exempt as are proposals in certain developing areas.

## Interim Review of the Plastic Shopping Bags Ban indicates that 'Canberrans Approve'

The *Plastic Shopping Bags Ban Act 2010* (the Act) came into effect in the ACT on 1 November 2011 following a four-month transition period. The objective of the Act is to restrict the supply of single-use, lightweight plastic shopping bags in the Territory and encourage the up-take of re-usable shopping bags.

In November 2012 the Interim Review of the Plastic Shopping Bags Ban was released. The Review surveyed consumer attitudes towards the ban and determined whether consumer behaviour had changed to reduce bag usage.

The survey results indicate that the ban has changed consumer behaviour, with 84 per cent of primary shoppers now taking re-usable bags always or most of the time when they go to the supermarket. Prior to the ban only 44 per cent of shoppers were using their own bags.

The majority of primary shoppers (58 per cent) supported the ACT Plastic Bag Ban, 33 per cent did not and 9 per cent were still unsure. While the majority of shoppers from every age group supported the ban, the responses by age suggest that the younger people are, the more likely they are to support the ban.

The research indicates that people who support the ban do so due to concerns about the environment. On the other hand, people who object to the ban felt that it wasn't effective in reducing the incidence of plastic bags in the waste stream, it was inconvenient or objected to having to purchase bin liners to replace the shopping bags they previously used.

When asked if they'd prefer to have the ban overturned 70 per cent of ACT primary grocery shoppers disagreed. Further, two-thirds (66 per cent) of shoppers indicated that they would like the ban to be implemented nationally.

# ACT Government Online Interactive Maps Updated to Include Significant Plants and Animals

ACTMAPi is the ACT Government's interactive mapping service. Nine of the most commonly used maps - basic map; aerial photography; territory plan; land custodianship; development applications; survey infrastructure; community interests; lease variation charge; and significant plants and animals - are available online. Members of the community can search the ACTMAPi for planning maps and associated information by block and section number, street address, division (suburb) or district names, or by places of interest.

The new version of ACTMAPi contains data on significant plants and animals, including threatened species and endangered ecological communities.

## **Green, Progressive and Proud – Shane Rattenbury MLA**

The ACT Conservation Council held a well-attended forum on the 20<sup>th</sup> February, with Minister Shane Rattenbury as their guest. Mr Rattenbury reflected upon his first 100 days holding the TAMS portfolio, where he is responsible for, among other things, land management in the ACT and its implications for biodiversity. Mr Rattenbury was positive about his first 100 days as the person who holds the balance of

power in the assembly, noting that it had a greater opportunity for stronger policies with respect to environmental conservation to be passed. He noted that "the Parliamentary Agreement which binds our Labor-Green Government for the next four years includes many Greens initiatives, including three which particularly relate to land management and biodiversity."

The ACT Greens want to merge existing ACT conservation services into a single Conservation Agency to achieve better integration of biodiversity policy, planning, research and management. Mr Rattenbury has requested that resources are provided for five additional Park Rangers, and secured \$7 million over the next 4 years for nature park improvements. This will include improved pest plant and animal management; operational plans for all reserves; and more support for Park Care groups and restoration work.

Mr Rattenbury concluded by saying that he looks forward to developing policy that will enhance land management and biodiversity while 'remaining aware that there are not unlimited resources and we will have to think smarter about how we get to the outcomes we want.'

## **Energy Efficiency Improvement Scheme has Commenced**

The Energy Efficiency Improvement Scheme (EEIS) started on 1 January 2013. The EEIS sets a Territory-wide energy savings target and includes obligations for ACT electricity retailers to meet an individual Retailer Energy Savings Obligation (RESO).

The Energy Efficiency (Cost of Living) Improvement Act 2012 provides the legal framework for the Energy Efficiency Improvement Scheme (EEIS). The Act contains the legal obligations and options that electricity retailers have under the scheme to meet their RESO, one of which is to undertake eligible energy savings activities. These activities are determined by the Minister for the Environment and Sustainable Development and must be carried out in accordance with codes of practice approved by the EEIS Administrator. Retailers incur penalties if they do not meet their targets. More information on the Energy Efficiency (Cost of Living) Improvement Act 2012 is available <a href="here">here</a>.

The EEIS will initially run until the end of 2015.

#### **Good News If You Like to Fish**

On 8<sup>th</sup> January 2013, recreational fishers and the environment benefited from the release of 6000 Murray cod fingerlings into Gungahlin Pond, with another 100,000 golden perch being released in urban waterways in the weeks following.

The release of the native fish formed part of the ACT Fish Stocking Plan and involved the ACT Government, National Capital Authority and Canberra Fisherman's Club. About 1.5 million fish have been introduced to Canberra's lakes and ponds since the program started in the mid-1990s. Species for stocking are chosen following biennial fish surveys.

The Environment and Sustainable Development Acting Director-General, Ben Ponton, said that "stocking our lakes provides both environmental and recreation benefits by increasing the number of native fish in our waterways and giving Canberrans greater opportunities for fishing closer to home".

"The program supplements existing native fish populations, which are currently dominated by introduced species. Introducing native species makes for a more balanced ecosystem as the native fish will compete with pest carp and, when adults, may even eat small carp."

"The Murray cod should be the legal angling size for recreational fishing in three to four years and the golden perch in two to three years."

## **Collaborating on Light Rail**

Recently Canberra Loves 40% met with Simon Corbell and discussed a proposal for a collaborative rather than a consultant approach to the Capital Metro light rail transit (LRT) project. This approach would include an Enquiry by Design process which would enable better consultative design work given the broad impacts likely on Gungahlin and the inner north areas. It is also a way of quickly generating design solutions while incorporating the knowledge and interests of a diverse group of people. The LRT project is more than just an infrastructure project, it is a transformational urban design project and an opportunity to design what a sustainable Canberra could look like. There is a wealth of knowledge and ideas in the community, and Canberra Love 40% believes the standard approach of consulting at the end of the process will neither tap into this community knowledge nor address the real concerns of the community. The opportunity to collaborate on this project could achieve a win-win for Government, the community and for business.

Canberra 40% had successfully lobbied for the 40% emission reduction for the ACT and has been given government funding to undertake a range of initiatives (now completed).

## Nearly Four Million Tonnes of Greenhouse Gas Emissions Saved in the ACT

The Independent Competition and Regulatory Commission (ICRC) has found that the ACT saved almost four million tonnes of greenhouse gas emissions over the life of the ACT greenhouse gas abatement scheme. The most recent ACT Greenhouse Gas Inventory Report 2010, which was released late last year, notes that:

- ACT emissions in 2009-10 increased by about 3% following an increase in 2009 of about 1.3% and a small decline in 2008
- Total emissions of greenhouse gases were 37.5% greater than 1990 levels.
- Electricity consumption contributes to 63% of our total emissions.
- Per capita emissions peaked in 2006 at 12.7 tonnes, and had reduced in 2009 to 12.2 with a slight increase in 2010 to 12.3 tonnes
- ACT renewable energy use increased from 11% in 2009 to 12.9% in 2010.

It is not good news that ACT emissions increased and that the slight downward trend in 2009 was not maintained. However, there are positive signs that the ACT may achieve the 15% renewable energy target by 2012. Click <a href="here">here</a> to read the Inventory Report.

## **Carmichael Coal Mine and Rail Project**

At every level the Carmichael coal mine and rail <u>project</u> is a bad idea. India's Adani Group is in the process of building Australia's largest coal mine, producing 60 million tonnes of coal per year during its 90 year lifespan. Specifically, the project would entail the digging of a 10,000 hectare coal mine, stretching over 40kms swallowing up farms, prime grazing land and the Bygana West Nature Refuge. When burnt for power generation, the coal would produce 128.4 million tonnes of carbon dioxide, which is greater than the 2009 carbon dioxide emissions from fuel combustion in Sweden, Norway and Denmark combined.

As a nation, we can't claim to be serious about stopping climate change and saving our reef while also allowing the creation of the largest coal mine we've ever seen - a mine that will see more damage to the Great Barrier Reef from dredging and the dumping of dredge spoils in the marine park.

New <u>research</u> by The Australia Institute shows how 'slowing down the pace of coal exports would actually result in enormous benefits to the Australian economy. It would allow our other key export industries – including manufacturing, tourism, education and agriculture – to expand, employing more people and paying more tax.<sup>1</sup>

# Solar Thermal energy costs expected to halve: CSIRO

Solar thermal energy will halve in cost by 2020, the new director of the CSIRO's <u>Australian Solar Thermal</u> <u>Research Initiative</u> (ASTRI) said today.

Solar thermal energy uses the concentrated heat of the sun to create steam, which turns a turbine and creates a clean, renewable power source. However, it remains expensive compared to other forms of energy due to fossil fuel subsidies and the limited operator hours of solar thermal energy power plants.

The CSIRO's \$87 million ASTRI, which brings together the country's top researchers in the field, aims to make solar thermal energy cheaper by developing new, more efficient technology and finding ways to reduce capital costs. ASTRI's new director, Dr Manuel Blanco, who has worked in the field for almost 30 years and was previously in charge of solar thermal energy at Spain's National Renewable Energy Centre (CENER), said Australia was well placed to lead research on the technology. Dr Blanco said the research centre would cut the cost of solar thermal energy to 12 cents a kilowatt hour by 2020, down from 25 cents a kilowatt hour now.

## Coming Ready or Not: Managing Climate Risks to Australia's Infrastructure

The Climate Institute has released *Coming Ready or Not: Managing climate risks to Australia's infrastructure*, a report which brings together research on the physical impacts and consequences of climate change on major infrastructure across property, electricity, road, rail and finance. It asks how prepared businesses and governments are to manage these risks, and the steps that will be required to improve Australia's climate change adaptation strategies.

The report reveals that Australia will face significant human and economic costs because our infrastructure is poorly equipped to handle more frequent extreme weather events and other consequences of climate change.

## **Case Law Update**

# Southern Highlands Coal Action Group Pty Ltd v Minister for Planning and Infrastructure

EDO NSW represented the Southern Highlands Coal Action Group (SHCAG) regarding its appeal in the Minister for Planning and Infrastructure's approval of expansion of activities in the Berrima Colliery by Boral Cement Ltd to 2020. SHCAG argued that Boral did not adequately consider the impact the project would have on the local groundwater resources, groundwater biodiversity, and the Wingecarribee River in preparing its environmental assessment.

The Land and Environment Court upheld SHCAG's appeal and refused the application on the basis that the project was not in accordance with the principles of ecologically sustainable development and in particular the precautionary principle. The Court found that the surface and groundwater issues were fundamental issues that could not be left for later resolution or adaptive management.

Importantly the Court also considered the State Environmental Planning Policy (Sydney Drinking Water Catchment) 2011 and the Sydney Catchment Authority's Neutral or Beneficial Effect on Water Quality Assessment Guideline 2011.

#### **Expert Panel Appointed to Assess Environmental Impacts of the Super Trawler**

The Federal Environment Minister has announced the Chair and Members of the expert panel to assess the environmental impacts of the super trawler. The four member panel, consisting of Ms Mary Lack, Professor Peter Harrison, Associate Professor Simon Goldsworthy, and Dr Kathy Bulman, will carry out an assessment of the environmental impacts of large mid-water trawl freezer vessels in the Small Pelagic Fishery under national environment law.

The expert panel will assess the declared commercial fishing activity to determine if the proposed fishing activity would adversely impact the Australian environment.

The terms of reference for the new expert panel have been developed in consultation with the Fisheries Minister.

The report from the expert panel must be presented to the Minister by **22 October 2014**, at which time a decision will be made as to the future of this kind of fishing activity.

#### **Coal Expansion Passed by Federal Environment Minister**

Earlier this month, a number of large coal and coal seam gas projects, including the controversial Whitehaven mine, were approved by the Federal Environmental Minister, Tony Burke.

Minister Burke signed conditional approvals for Whitehaven's Maules Creek mine, planned for the Leard State Forest, Idemitsu's neighbouring Boggabri coalmine expansion, and a coal seam gas development planned by AGL for Gloucester in NSW. Together, these three projects would have a huge carbon footprint of 47 million tonnes of greenhouse gases a year – about 8 per cent of Australia's total emissions – according to environmental impact assessments.

The mining projects had all been approved at state level. Minister Burke's signature was seen as a final obstacle to development.

# Mining approved for the Tarkine

The Federal Environment Minister, Tony Burke, has rejected the Heritage Council's advice to protect more than 400,000 hectares of the mineral-rich Tarkine region in north-west Tasmania. He said "from purely environmental terms, it would have been something that would have been a wonderful thing to be able to do but you have to take into account the impact on people and taking that impact into account meant that I simply couldn't go with the Heritage Council's recommendations". ## **UN Environment Programme report on thawing permafrost**

The United Nations Environment Programme (UNEP) has released a report revealing that permafrost covering almost a quarter of the northern hemisphere contains 1,700 gigatonnes of carbon, twice the carbon that is currently in the atmosphere. The thawing of this permafrost could significantly increase global warming if it accelerates as projected. It is not yet accounted for in climate change predictions but is likely to cause significant global warming. The report 'Policy Implications of Warming Permafrost' was released on the second day of COP 18 climate talks in Doha.

The majority of current permafrost formed during or since the last ice age. It extends to over 700 meters deep in parts of northern Siberia and Canada. The permafrost is made up of an active layer up to two metres in thickness which thaws every summer and refreezes every winter, as well as permanently frozen soil beneath.

If the active layer increases in thickness because of global warming, vast quantities of organic matter stored in the frozen soil would thaw and decay, releasing large amounts of carbon dioxide and methane into the atmosphere.

This process would trigger the permafrost carbon feedback, which has the effect of increasing surface temperatures and accelerating the further thawing of permafrost. This process would be irreversible.

#### **Rights of Nature case in Ecuador**

Ecuador is facing one of its most challenging cases for Rights of Nature - which is a right guaranteed in the Ecudorian Constitution - as the government moves ahead with a contract for open pit mining in The Condor Highland, which is one of the most biodiverse areas of South America. In March 2012, the government of Ecuador signed a contract with Ecuacorrientes (ECSA), a company of Chinese capital to extract copper, gold and silver from the Condor Highland via open pit mining in south eastern Ecuador.

Environmental, human rights, and indigenous organizations, along with local community members from the Condor region in Ecuador have joined together to file a lawsuit to stop the Mirador Mining Project. The suit claims that the mine would violate the protected rights of ecosystems guaranteed in the Articles 71-73 on Rights of Nature in the Ecuadorian Constitution.

# Now for the downside of fracking

In rural Pennsylvania, USA, residents live side by side with America's new shale gas boom and the associated wells which drill and fracture for gas (commonly known as 'fracking'). Locals are beginning to question the risks involved in the contamination of air (pollution from the gas wells and compressor stations) and drinking water (with methane) from which the drilling companies and the local environmental protection agency say they are not in danger - or at least, they say none of the contaminants in the air or water can be traced directly to the well. One pressure group, the Pennsylvania Alliance for Clean Water and Air, has collated more than 800 cases of people they say have been harmed by fracking nationwide - a body of evidence that environmentalists and local politicians contend is now beyond anecdotal.

As New York and Colorado debate whether to allow fracking, environmental groups and some residents in Pennsylvania argue that the long-term health impacts of fracking so close to residential communities are just too indeterminate to be considered safe. They say two official studies on the impact of fracking on water quality and radiation build-up are not even due to be completed until next year. A local Senator, Richard Kasunic, admits that the regulatory framework for the industry is a "work in progress" and that "we're flying by the seat of our pants here". And that, concludes Jesse White, a Pennsylvania state representative who has taken up the cause of those who say they have been affected by the shale gas boom, is the lesson that other countries should learn if and when they move to exploit shale gas reserves.

# **Opportunities to Comment - ACT**

## Strategic assessment of urban development at Gungahlin, ACT

On 2 October 2012, the Department of Sustainability, Environment, Water, Population and Communities entered into an agreement with the ACT Government Environment and Sustainable Development Directorate and the ACT Government Economic Development Directorate to undertake a strategic assessment of proposed urban development at Gungahlin, ACT. The strategic assessment will be undertaken in accordance with section 146 of the *Environment Protection and Biodiversity Conservation Act 1999* (EPBC Act).

On 16 January 2013 the strategic assessment agreement was varied to reflect the expansion of the strategic assessment to include the additional suburb of Moncrieff. Parts of the suburbs of Crace and Horsepark North have been removed from the agreement because these areas will now be retained for conservation. All parties to the agreement have signed and agreed to the changes.

A strategic assessment is taking place because environmental studies have identified several matters of national environmental significance protected under the EPBC Act. These include the threatened Superb Parrot, Regent Honeyeater, Striped Legless Lizard, Golden Sun Moth and the threatened ecological community of White Box-Yellow Box-Blakely's Red Gum Grassy Woodland and Derived Native Grassland and (potentially) Natural Temperate Grassland of the Southern Tablelands of NSW and the Australian Capital Territory. # Nominate a Species, Ecological Community or Key Threatening Process under the EPBC Act

Nominations are open for the assessment period starting 1 October 2013 for any threatened species, threatened ecological communities or key threatening processes to be considered for listing under national environment law. Nominations for this assessment period may be submitted until **5pm on Thursday 28 March 2013**.

### Draft Environmental Water Recovery Strategy for the Murray-Darling Basin

The draft Environmental Water Recovery Strategy outlines the Government's future approach to environmental water recovery in the Murray-Darling Basin. This includes water recovery through investment in more efficient water delivery infrastructure, environmental works and measures and water purchase. Further details are on the website.

# COAG's Standing Council on Energy and Resources are seeking comment on the Draft National Harmonised Regulatory Framework for CSG

The National Harmonised Regulatory Framework is a guidance and reference tool for Australian federal, state and territory government regulators for the Coal Seam Gas (CSG) industry. Its purpose is to provide a suite of national and global leading practices to consider and implement in the assessment and ongoing regulation of proposed CSG projects.

The concerns and issues raised by the community regarding CSG development in Australia to date have warranted the attention of governments and industry. As a result, in December 2011, governments through COAG's Standing Council on Energy and Resources responded by agreeing to develop the Framework.

The draft National Harmonised Regulatory Framework public consultation closed on **28 February 2013**, however all stakeholders are welcome and encouraged to make a written submission. For more information, and to access the submission template, follow this <u>link</u>.

#### Inquiry into the Impacts on Health of Air Quality in Australia

The Senate has referred this inquiry to the Community Affairs References Committee for inquiry and report by 16 May 2013. The terms of reference for the inquiry relate to the impacts on health of air

- particulate matter, its sources and effects;
- those populations most at risk and the causes that put those populations at risk;
- · the standards, monitoring and regulation of air quality at all levels of government; and
- any other related matters.

## Productivity Commission Inquiry into Mineral and Energy Resource Exploration

The Australian Government has asked the Productivity Commission to undertake a 12-month inquiry into the non-financial barriers to mineral and energy resource exploration.
