## **Water Use Inquiry Discontinued**

Prior to the recent ACT election, the then ACT Legislative Assembly Planning and Environment Committee postponed its inquiry into water use and management due to the Committee's workload. The inquiry was to address the best options for maintaining a sustainable water supply in the ACT and the likely impacts of climate change.

#### **New Tax Incentives for Green Cars**

The ACT has introduced legislation which means that motorists purchasing a car in the ACT will pay a stamp duty that corresponds to the environmental rating of the car. Those with the highest environmental rating will be exempt from stamp duty all together; whilst cars with higher emission levels will attract a higher tax. Cars will be rated according to the Commonwealth Government's Green Vehicles Guide (available at <a href="https://www.greenvehicleguide.gov.au">www.greenvehicleguide.gov.au</a>) and a greenhouse rating (based on a car's carbon dioxide emissions and air pollution rating. The scheme aims to encourage Canberra motorists to buy low-emitting cars and acts as a disincentive against the purchase of cars with poor environmental performance.

## **ACT State of Environment Report 2007/08 Released**

ACT Environment Commissioner Maxine Cooper launched the 2007/08 ACT State of the Environment Report on 7 August. The report provides an update on environmental trends and pressures experienced in the ACT since 2003. Amongst other things, the report found that Canberrans create more waste than anyone else in Australia and the use of most resources has increased. The report makes recommendations to the ACT Government and calls upon individuals to make better choices in their day-to-day lives.

## ACT Passes Australia's First SLAPPs Legislation

The ACT became the first Australian jurisdiction to introduce SLAPPs (strategic litigation against public participation) legislation when the Legislative Assembly passed the *Protection of Public Participation Act 2008*, introduced as a Private Member's bill by recently retired Greens MLA Dr Deb Foskey.

The Act is designed to restrict the use of SLAPPs, a form of vexatious litigation used to silence individuals who speak out on issues of public interest. Under the new legislation, individuals have a right to public participation, and courts may dismiss proceedings which are intended to stifle public debate. Before legal action is commenced against them, individuals may apply to the Magistrates Court for a declaration that their conduct constitutes 'public participation' under the Act. This is intended to discourage potential litigants from commencing proceedings, and could also serve to reassure other members of the public that they are likely to be protected from vexatious lawsuits, should they too speak out.

EDO ACT has in the past supported anti-SLAPP legislation and is pleased with the passage of this law. It is hoped that the legislation will help to protect the public's right to participate freely in matters of public interest. #### A Solar Power Plant for Canberra?

Canberra may be one step closer to becoming a solar capital. Prior to the recent ACT election the Chief Minister Jon Stanhope promised to push ahead with plans for a large scale solar power plant in the ACT if re-elected. The announcement followed the release of a study in September 2008 commissioned by the Government and ActewAGL which suggested a 22MW solar thermal trough facility could be operational by 2012 and power up to 10,000 homes. Such a facility would require a large parcel of land, and a substantial public investment in the project to make it economically feasible for interested parties in the private sector.

## **Draft Natural Resource Management Plan released**

The ACT Natural Resource Management Council has recently developed and released a draft ACT Natural Resource Management (NRM) plan, entitled *Bush Capital Legacy*. The Plan revises the first NRM plan published in 2004, to take into account changes in values and environmental status since that Plan was published. It is designed to assist in the management of the ACT's natural resources. The Plan proposes targets to improve the sustainability of the ACT's natural resources, and provides strategic direction for government, community and private investment in these natural resources.

The Plan warns that although some indicators of environmental health in the ACT have improved, the continued growth in consumption by the ACT's population is alarming and unsustainable. Canberra's status as the "bush capital", the Plan says, is at risk from the increasing urban footprint of the city, and the deterioration in the health of the bushlands

within and around Canberra.

## **Molonglo and North Weston Strategic Assessment**

The Federal Environment Minister and the ACT Minister for Planning have agreed to undertake a strategic assessment of the proposed Molonglo and North Weston Structure Plan under the *Environment Protection and Biodiversity Conservation Act 1999* (EPBC Act). The Structure Plan sets out the planning and development guidelines and principles for urban development and associated infrastructure at Molonglo and North Weston.

A strategic assessment is being undertaken as preliminary environmental investigations in the Molonglo and North Weston area have identified several matters of national environmental significance. These include the Pink-tailed Worm-lizard, listed under the EPBC Act as vulnerable, and the White Box-Yellow Box-Blakely's Red Gum Grassy Woodland and Derived Native Grassland and the Natural Temperate Grasslands of the Southern Tablelands of NSW and the ACT listed as critically endangered.

Draft assessment Terms of Reference have been developed, to guide the preparation of a report identifying the area's environmental values (including matters of national environmental significance), the impacts of development and strategies to reduce impacts on matters of national environmental significance.

#### **News From Around Australia**

#### **Federal Government Extends Gunns Deadline**

The Federal Environment Minister, Peter Garrett, has extended the deadline for timber giant Gunns Ltd. to submit an Environmental Impact Management Plan for its proposed pulp mill in the Tamar Valley of northern Tasmania.

Submission of the Management Plan by October 2008 was one a number of conditions attached to the government's approval of the project in 2007, under the *Environment Protection and Biodiversity Conservation Act 1999*. The extension of the deadline has been harshly criticised by Australian Greens Senator Christine Milne.

Gunns now has until January 5, 2009 to complete the Management Plan.

## **Priority Assessment Lists**

The Commonwealth Department of the Environment, Water, Heritage and the Arts has released the finalised priority assessment list for the threatened species, ecological communities and key threatening processes nominated for inclusion under the *Environment Protection and Biodiversity Conservation Act 1999*, that will be assessed by the Threatened Species Scientific Committee for the assessment period commencing 1 October 2008.

The most recent list includes species such as the Tasmanian Devil and the koala and includes the ecological communities of the Cumberland Plain Woodlands and the Lower Murray River and associated wetlands.

## **Environment Minister Acts Under the EPBC Act to Protect False Cape and Shoalwater Bay**

Federal Minister for the Environment, Peter Garrett, has suspended approval of the Reef Cove Resort development at False Cape in Queensland. This decision was based on the Minister's concerns regarding the threat of sediment run-off into the Great Barrier Reef World Heritage Area.

The Minister has ordered that no construction take place on the site until an environmental audit has been carried out by the developer and he is satisfied that appropriate remediation work has been completed and construction is able to be completed in full compliance with the approval conditions, without impacting on the marine environment.

The Minister has also announced his decision to preserve the biodiversity values at Shoalwater Bay north of Rockhampton in Queensland, by rejecting a proposal by Waratah

Coal Inc. to establish a rail line and coal port in the Shoalwater Bay Training Area.

Mr Garrett found the proposal would have "clearly unacceptable impacts on the internationally recognised Shoalwater and Corio Bay Ramsar wetlands and the high wilderness value of Shoalwater which is acknowledged in its Commonwealth Heritage listing."

## Treaties Committee Supports the Protection of Endangered Fauna and Flora

The Federal Parliament Treaties Committee has supported amendments to the Convention on International Trade in Endangered Species (CITES) of Wild Fauna and Flora subject to a number of recommendations. The CITES Convention provides for international cooperation to protect and conserve certain species of fauna and flora from over-exploitation due to international trade.

The amendments will alter the level of control imposed upon trade in a number of species that are either endangered or at risk of becoming endangered, including Australia's sawfish.

The Committee also recommended that Australia take binding treaty action in relation to the 2006 International Tropical Timber Agreement, and that any future agreement on sustainable trade in tropical timber should specifically include consultation with environmental groups.

#### **Cotter Dam Expansion**

ACTEW has prepared a draft environmental impact statement for a project designed to increase the capacity of the Cotter Reservoir from 4 gigalitres (GL) to 78GL, raising the ACT's overall storage capacity by a third. The proposal involves the construction of a new dam wall and two saddle dams on the adjacent ridge.

Comments have been sought on the draft EIS.

#### Commonwealth Water Act 2007 – proposed amendments

The Senate is currently inquiring into the Water Amendment Bill 2008. The Bill amends the *Water Act 2007* to make changes to the cooperative water planning, management and regulatory regime in the Murray Darling Basin. In particular, the Bill reflects an agreement by the relevant States and the ACT to refer constitutional powers to the Commonwealth. Further information is found here:

## **Litigation News**

## Special Leave Application Lodged in Walker Case

The NSW EDO recently filed an application for special leave to appeal to the High Court of Australia in the ongoing matter of *Jill Walker v the Minister for Planning*.

The EDO successfully represented Jill Walker in her challenge to a concept plan approval granted by the Minister for Planning for a development at Sandon Point, north of Wollongong. Justice Biscoe of the Land and Environment Court found that the Minister had failed to consider matters of ecologically sustainable development (ESD) by not taking into account the potential impacts of climate change on the site. Following an appeal by the Minister, the NSW Court of Appeal overturned Biscoe J's decision, finding that whilst the Minister must make decisions in the public interest, not having regard to ESD principles does not necessarily constitute a breach of that obligation.

If special leave is granted, the EDO will again argue that the Minister should be required to

consider ESD as a mandatory relevant consideration under part 3A of the *Environmental Planning and Assessment Act 1979* (NSW).

## **Victorian Supreme Court Considers the Precautionary Principle**

In Western Water v Rozen & Ors [2008] the applicants sought permission to build on 4 separate lots, all of which fronted the Campaspe River. Each house would have a septic system. The river flows into the Campaspe Reservoir which provides drinking water for Woodend. Macedon Shire Council rejected the proposal on a range grounds including water quality. The matter went to VCAT. The State Environment Protection Policy (Waters of Victoria) requires the application of the precautionary principle. Applying the precautionary principle, VCAT found that there was no real risk of irreversible harm to the environment.

This was appealed to the Supreme Court. Justice Osborn found that VCAT had failed to correctly apply the precautionary principle. VCAT did not identify or address the concept of risk of "serious" as distinct from irreversible damage to the environment and did not assess the gravity of the risk against the relevant test but rather substituted a misconceived test requiring a risk of irreversible damage.
